Terms & Conditions of booking

Deposit & Payment

A £100 non-refundable deposit is payable at time of making the booking

The remaining balance is to be paid two weeks prior to the wedding.

Travel Expenses

If the wedding venue is more than 25 miles from the photographers location a charge of £0.40 per mile will be levied.

Usage of images

The client is permitted to display any low resolution images (700 pixels at 72dpi on the longest dimension) supplied on digital media for non commercial usage on their personal website or blog, facebook page or other social networking website provided that any watermark or text placed upon the image by the photographer is left intact and not obscured or altered in any way.

The client is also permitted to make one backup copy of any images supplied as digital media.

The photographer reserves the right to use any images taken during any commissioned photoshoot or event (such as a wedding or engagement) for advertising and promotional purposes in both print and digital media online.

Reproduction of purchased prints by any means or process is strictly forbidden and shall be deemed a breach of my copyright in respect of the image/s concerned.

Limitations placed upon the photographer at a church, chapel or other venue

By commissioning the photographer for a wedding photoshoot you agree that the photographer may have limits placed upon him by the Minister or Officiant in regards to taking photographs during the wedding or use of flash photography. In such circumstances coverage of the event and quality of the resulting images may be affected.

Termination and cancellation

1.FORCE MAJEURE: A party is not liable for failure to perform the party's obligations if such failure is as a result of Acts of God (including fire, flood, earthquake, storm, hurricane or other natural disaster), war, invasion, act of foreign enemies, hostilities (regardless of whether war is declared), civil war, rebellion, revolution, insurrection, military or usurped power or confiscation, terrorist activities, nationalization, government sanction, blockage, embargo, labour dispute, strike, lockout or interruption or failure of electricity or telephone service. No party is entitled to terminate this Contract in such circumstances.

2.If a party asserts Force Majeure as an excuse for failure to perform the party's obligation, then the non performing party must prove that the party took reasonable steps to minimize delay or damages caused by foreseeable events, that the party substantially fulfilled all non-excused obligations, and that the other party was notified in a timely manner of the likelihood or actual occurrence of an event described in Clause 1 (Force Majeure).
